Recommendations to avoid the spread of COVID-19 continue to include social distancing, wearing masks and limiting congregations of groups of people.

CCARS cannot guarantee that you, your child(ren), other members of your household, your relatives and any of your guests who attend the Feis (collectively, "You and Your Attendees" and any one individually "You" or "Your Attendees") will not become infected with COVID-19 at the Feis or as a result of having attended the Feis. Further, You and Your Attendees' attendance at the Feis could increase the risk of You and Your Attendees contracting and/or transmitting COVID-19.

You and Your Attendees fully understand that the risk of becoming exposed to or infected by COVID-19 at, or as a result of attending, the Feis may result from the actions, errors, omissions, or negligence of CCARS and/or any of its members, families, officers, directors, affiliates, agents, employees, volunteers, participants, vendors, agents and contractors, including, but not limited to, Casey O'Loughlin Academy, Cara O'Loughlin and Mark O'Loughlin, all of whom are hereinafter collectively referred to as the "Releasees".
- 3. You and Your Attendees' attendance at the Feis is completely voluntary and You and Your Attendees each assume the risk of attending the Feis.
- 4.
